2025 HEALTHFLEX ANNUAL OPEN ENROLLMENT PERIOD

- The Annual Open Enrollment Period is from 10/30 11/14.
- Do I need to enroll, if I am not making any changes to my healthcare elections from last year?
 - Yes, if you are a local pastor appointed 100%.
 - Yes, if you are an Elder, Deacon, Associate and Provisional Members appointed 75% or more.
 - Yes, if you are a Conference/ District Staff member working 30 hours or more per week.
- But I "Waive/Decline" the HealthFlex Coverage:
 - Great, then you MUST complete the <u>HealthFlex Waiver Form</u>, each year, and return to Stacy Jefferson at <u>sjefferson@wocumc.org</u>.
- What happens if I do not enroll before the deadline?
 - Your healthcare coverage may automatically default to H5000 single coverage, and you will not be eligible to participate in an HSA.

 - ✓ The HSA contribution limits for 2025 are \$4,300 for self-only coverage and \$8,550 for family coverage. Those 55 and older can contribute an additional \$1,000 as a catch-up contribution.
 - ✓ Only the plan sponsor may contribute funds to an HRA for its employees.
 - ✓ The health care (standard or limited) FSA annual maximum plan contribution limit is projected to increase from \$3,200 to \$3,300 in 2025. The health care (standard or limited) FSA rollover maximum limit is projected to increase from \$640 to \$660 in 2025.
- Can you explain why my healthcare plan deductible increased by \$250 for single coverage and \$500 for family coverage?
 - Sorry to hear about the increase in your deductible. This change is linked to the Health Check Questionnaire requirement for all HealthFlex participants and their spouses. Everyone was expected to complete the questionnaire by August 30, 2024. If you or your spouse did not complete it, that's the reason for the deductible increase.
